I. Call to Order

The meeting was called to order by Mayor Jerri Medrano.

II. Invocation

The Invocation was led by Alderman Tim Hatten.

III. Pledge of Allegiance

IV. Consent Agenda

Mayor Jerri Medrano asked to approve the Consent Agenda Items including the Police Department Summary for February 2015, the Water Department Summary for February 2015, the Permit Report for February 2015, and the Monthly Financials for February 2015.

Motion was made by Alderman James Mizell and seconded by Alderman Jake Walker.

VI. Discussion Items

1. Discuss changing from every two years to yearly appointing Mayor Pro Temp.

There was much discussion regarding making a change or not. The Council agreed to have it on the May Agenda as an Item to be Considered.

2. Discuss changing spending limitations of departments without prior Council approval.

3. Discuss procedures of sending letters to people without prior Council approval.

4. Discuss security procedures for all parades in the City limits.

VII. Items to Be Considered

1. Consider and act upon the approval of the Minutes of February 17, 2015.

Motion was made by Alderman Jake Walker and seconded by Alderman Gary Nash. Motion carried. 4 Ayes; 0 Nays; and 1 Abstention

2. Consider and act upon approving Resolution 2015-03 of the changes to the Employee Manual.

Motion was made by Alderman Jake Walker and seconded by Alderman Tim Hatten. Motion carried. 4 Ayes; 0 Nays; and 1 Abstention

3. Consider and act upon approving Ordinance 2015-01 making the necessary changes and updating the current Solicitor's Ordinance 01-82-01-83.

City Secretary Kim Smith explained to the Council that the Solicitor's Ordinance had not been updated since 1983 and there have been new laws in place. There was also an exception that has been added regarding Alarm Companies can come into our City and not have to get a Solicitor's Permit, as long as they have a separate license from the State of Texas.

Motion was made by Alderman Jake Walker and seconded by Alderman Tim Hatten. Motion carried. 4 Ayes; 0 Nays; and 1 Abstention

4. Consider and act upon approving deactivating the Beautification Committee.

The Council made a motion to table this item until the June 2015 Council Meeting. They will discuss whether to keep the Committee active or deactivate it at that time.

Motion was made by Alderman Jake Walker and seconded by Alderman Tim Hatten. Motion carried. 4 Ayes; 0 Nays; and 1 Abstention

Alderman Gary Nash stated that he has been getting a lot of phone from residents regarding the City's Streets. He also asked if the Council would able to discuss at that time. Mayor Jerri Medrano stated no, because it wasn't on the agenda.

Alderman Tim Hatten asked for the next meeting agenda, to have a discussion on City Streets, and have the Park Committee come give the Council an update on their plans for the City Park.
