I. Call to Order

The meeting was called to order by Mayor Pro Tem James Mizell.

II. Invocation

The Invocation was led by Mayor Pro Tem James Mizell.

III. Pledge of Allegiance

IV. Canvass of Votes of May 9, 2015 City General Election

1. Presentation, discussion, and action of Resolution 2015-04 of the City Council of the City of Hallsville, Texas, canvassing returns and declaring results of the General City Election, held on May 9, 2015, for the purpose of electing a Mayor and two Alderman Positions at large.

Kimberly Smith, City Secretary canvassed the votes and requested from the current council to approve Resolution 2015-04.

2. Administer Oath of Office and presentation of Certificates to Mayor and two Aldermen.

Kimberly Smith, City Secretary administered the Oath and present the Certificates too Steve Eitelman, Mayor; Dan Herrington, Alderman; & Charlie Hunt, Alderman.

The Meeting was turned over Mayor Steve Eitelman.

Mayor Steve Eitelman presented to Mayor Pro Tem James Mizell a Proclamation for his 28 years of service to the City of Hallsville, the Hallsville residents, and the throughout the community.

Motion was made by Alderman Charlie Hunt and seconded by Alderman Eric Anderson Motion carried. 5 Ayes; 0 Nays; and 0 Abstention

3. Consider and act upon the approval of the Financial Statements and Independent Auditor's Report for September 20, 2014 by Mike Hallum.

Mike Hallum briefed the council on certain sections of the audit. Overall, the City of Hallsville had a good audit for FY 2013-2014.

Motion was made by Alderman Jake Walker and seconded by Alderman Tim Hatten Motion carried. 5 Ayes; 0 Nays; and 0 Abstention

4. Consider and act upon approving Resolution 2015-05 for SWEPCO Card.

Alderman Jake Walker explained to Mayor Steve Eitelman the reason for this resolution.

Motion was made by Alderman Dan Herrington and seconded by Alderman Eric Anderson Motion carried. 5 Ayes; 0 Nays; and 0 Abstention

5. Consider and act upon approving Resolution 2015-06 Expenditure Policy.

Motion was made by Alderman Jake Walker and seconded by Alderman Charlie Hunt Motion carried. 5 Ayes; 0 Nays; and 0 Abstention

6. Consider and act upon approving the Resignation of Tim Hatten for Alderman effective May 19, 2015.

Alderman Tim Hatten read aloud his letter of resignation and thanked the Council and the public.

Motion was made by Alderman Jake Walker and seconded by Alderman Charlie Hunt Motion carried. 4 Ayes; 1 Nays; and 0 Abstention

Mayor Steve Eitelman presented to Alderman Tim Hatten a Thank You Certificate for his years of service as Alderman for the City of Hallsville.

7. Consider and act upon approving the appointment of a replacement Alderman to fill the vacancy caused by the resignation of Alderman Tim Hatten.

Alderman Jake Walker recommended that this item be tabled to the June meeting so it will give the Council members time to think of a replacement. The council agreed to table this until the June 16, 2015 meeting.

Motion was made by Alderman Jake Walker and seconded by Alderman Charlie Hunt Motion carried. 5 Ayes; 0 Nays; and 0 Abstention
