Sales Tax Usage Update

Since our last newsletter, the State of Texas has passed a new law that affects how cities allocate the funds collected through sales tax. This change is effective September 1, 2015, and is favorable for the City of Hallsville. All funds collected can be used as part of Cities general revenue and not restricted as the previous law required. We are planning to have this proposal on the May Election ballot. We will keep you updated as we get closer to the May Election. If you have any questions, please give us a call.

The City of Hallsville has entered into an agreement with Public Management Inc., a firm that specializes in developing and implementing short and long term goals for small to midsize towns. The first phase of our planning involves mapping which will give details of Land Use (existing & future) of zoning & options. The second phase of this agreement will involve developing, writing and implementation of zoning ordinances. With our continuing development inside Hallsville, we feel that planning for long-term, controlled growth is necessary to protect the property owners inside our City.
