### CITY OF HALLSVILLE, TEXAS CITY COUNCIL MEETING JANUARY 21, 2014 MINUTES

The City of Hallsville Council meeting convened in regular session at 6 P.M. on Tuesday, January 21, 2014, at City Hall located 115 Main Street.

#### I. CALL TO ORDER

The meeting was called to order by Mayor Jerri Medrano.

The Invocation and the Pledge of Allegiance was led by Mayor Medrano.

#### II. CONSENT AGENDA

1. Approval of the November 19<sup>th</sup>, 2013, minutes.

Motion was made by Alderman Eric Anderson and second by Alderman Gary Nash. Motion carried. 5 Ayes; 0 Nays: and 0 Abstentions.

2. Monthly Financial Reports for November and December, 2013

Paul Jasin with Specialized Public Finance Inc. made a special announcement in reference to Standard & Poor's Ratings Services assigned its 'AA' rating to Hallsville, Texas' series 2014 General Obligation (GO) Refunding Bonds and Series 2014 Certificates of Obligation. The Outlook is Stable.

Alderman Tim Hatten asked the question, "why is the December payroll expenses up for this month. Faron Cane explained due to the three pay periods in December.

Motion was made by Alderman Jake Walker and second by Mayor Pro Tem James Mizell. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

After the motion was made Alderman Tim Hatten asked the question "what are we repairing"?

Mayor Jerri Medrano responded with water leaks and repair on water lines. Faron Cain responded with \$14,000 was for clearing and mowing of right-of-ways. There was another large check to JW Electric for the Ran System and circuit boards; York Pump for \$5,000 for the lift station repairs.

Tim Hatten asked the question "what about Capital Improvements"?

Mayor Jerri Medrano responded with "this amount went for fencing for the water tower".

#### III. MONTHLY POLICE SUMMARY

The November Police Summary was reviewed by Mayor Jerri Madrano. Total contacts for the month were 257: 93 citations issued and 75 warnings issued. There were 18 incident reports, 14 arrest and 5 accidents for the month.

The December Police Summary was reviewed by Mayor Jerri Medrano. Total contacts for the month were: Total contacts for the month were 154: 91 citations issued and 63 warnings issued. There were 17 incident reports, 9 arrests and 3 accidents for the month.

#### IV. MONTHLY WATER DEPARTMENT SUMMARY

Rickey Dugger reported there were 4 contractors in town, 5 lift station repairs, 2 sewer lines installed, 1 sewer service line, 15 line locates.

Rickey explained how locating lines take a lot of time to locate without locator wire. With gas companies coming to town, we need to stay ahead of them.

Rickey continued with 4 after hours call outs, 2 wastewater pumps pulled, 2 days of repairing lights at sewer plant, 12 days of running system manually, 9 meters installed and 2 manholes fixed.

Rickey explained there were trucks that ran off the road and hit the manhole covers. This was an added expense.

#### V. ITEMS TO BE CONSIDERED

Consider and act upon approving a Resolution 2014-21-01 authorizing signatory agents,
Mayor Jerri Medrano, Mayor Pro Tem James Mizell and City Secretary, Judy Adkisson; will
be only signers.....all other previous signers will be removed from each account and cd's (at
maturity) for the City of Hallsville Bank Accounts at Guaranty Bond Bank and Texas Bank and
Trust.

Motion was made by Alderman Eric Anderson and second by Alderman Gary Nash. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

2. Consider and act upon the replacement for liaison for the Beautification Board replacing Laura Welch with Judy Adkisson.

Motion was made by Alderman Jake Walker and second by Alderman Eric Anderson. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

3. Consider and act upon approving an amendment to the Commercial/Residential Sub-Division Site Plan Review/Inspection fee from 3% to 2%.

Mayor Jerri Medrano explained that the Commercial/Residential Sub-Division Site Plan Review/Inspection fee was mistakenly printed as 3% and should have been 2%.

Motion was made by Alderman Eric Anderson and second by Mayor Pro Tem James Mizell. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

4. Discussion and consider adoption of an ordinance authorizing the issuance and sale of City of Hallsville, Texas, General Obligation Refunding Bonds, Series 2014, in an aggregate principal amount not to exceed \$2,865,000; levying a tax in payment thereof; authorizing the execution and delivery of a bond purchase agreement and a paying agent/registrar agreement; calling certain prior obligations for redemption; approving the official statement; finding and determining that the meeting at which this ordinance is passed is open to the public as required by law; and enacting other provisions relating thereto.

Paul Jasin with Specialized Public Finance Inc. asked if council would like for him to report both bonds together or separate?

Alderman Eric Anderson responded for the bonds to be handled separately.

Paul Jasin referred to page 5, in his hand-out booklet and stated the goal was to keep the interest cost down and the payment close to what the City of Hallsville was paying for on the 2012 bond, having a new money debt without a rate increase. He reported today (January 21, 2014) six bids came in with Comerica Securities with the winning bid of 2.285119%. He stated this was a very good interest rate.

Paul Jasin referred to page 7, in his hand-out booklet and stated the refunded bonds for the series 2008 C/O with 2014 through 2028 has an interest rate of 4.573% with the amount of \$1,800,00 and the series 1998 WWSS with 2014 through 2019 has an interest rate of 4.25% - 4.45% with the amount of \$1,140,000 and refunded bonds with a total of \$2,940,000.

On to the final summary of results, the estimated true interest cost 2.289%. Total debt service savings \$315,327 and net present value savings of \$249,684 and what stands alone is net present value savings of 8.493%.

Motion was made by Alderman Jake Walker and second by Alderman Eric Anderson. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions

5. Discussion and consider adoption of an ordinance providing for the issuance and sale of City of Hallsville, Texas, Combination Tax and Revenue Certificates of Obligation, series 2014, in a maximum aggregate principal amount of \$5,160,000; levying a tax in payment thereof; authorizing the execution and delivery of a purchase contract relating to said Certificates of Obligation; authorizing the execution and delivery of a paying agent/registrar agreement; approving the official statement; finding and determining that the meeting at which this ordinance is passed is open to the public as required by law; and enacting other provisions relating thereto.

Paul Jasin referred to page 3 of his hand-out booklet and reported we received today (January 21, 2014) 4 bids for Certificates of Obligation Bid Summary –True Interest Cost. BOSC, Inc. came in as the winning bid of 3.472215%.

There was much discussion about the above two bonds and the benefits to Hallsville, Texas.

Motion was made by Alderman Eric Anderson and second by Alderman Jake Walker. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

6. Consider and act for approval of updating our Use of Force Policy for the City of Hallsville Police Department.

Police Chief Montoya stated the purpose of this policy is to provide law enforcement officers with guidelines for the use of deadly and non-deadly force. This policy does not set forth a higher standard of care with respect to third party claims.

Police Chief Montoya stated the definition of deadly force is any use of force that creates a substantial risk of causing death or serious bodily injury. Non-deadly force any use of force other than that which is considered deadly force. This includes any physical effort used to control or restrain another, or to overcome the resistance of another.

There was much discussion and examples reported.

Motion was made by Alderman Eric Anderson and second by Alderman Jake Walker. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

7. Consider and act for approval of Racial Profiling Report for the Citiy of Hallsville Police Department.

Motion was made by Alderman Tim Hatten and second by Alderman Gary Nash. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

NOTE: I was called away from minutes for a period of time.

8. Consider and act of approval of the Bias Based Policing Report 2013 for the City of Hallsville Police Department.

Motion was made by Alderman Tim Hatten and second by Alderman Gary Nash. Motion carried. 5 Ayes; 0 Nays; and 0 Abstentions.

#### VI. CITIZENS TO BE HEARD

The city Council welcomes public comments on items not specifically listed on the agenda. Speakers must sign up before the meeting begins and indicate which item (if any) the speaker wishes to address. Speakers are limited to three (3) minutes each. 


