The meeting was called to order at 6:00 pm by Mayor Jesse Casey.

VI. **Consent Agenda – January 2021**

Mayor Jesse Casey asked to approve the Consent Agenda Items including Police Department Summary for January 2021, the Water Department Summary for January 2021, the Permit Report for January 2021, the Monthly Financials for January 2021, and the January 19, 2021 Regular Meeting Minutes.

Motion was made by Alderman Brant Cain, seconded by Alderwoman Lauren Bresch, to approve the January 2021 Consent Agenda as presented. The motion carried unanimously.

VII. **Consent Agenda**

Mayor Jesse Casey asked to approve the Consent Agenda Items including the City Administrator's Report for January and February 2021, Police Department Summary for February 2021, the Water Department Summary for February 2021, the Permit Report for February 2021, and the Monthly Financials for February 2021.

Alderman Brant Cain asked about the water accountability difference on the Water Department Summary Report. City Administrator Marty Byers stated because of the timeperiod difference between the amount of water purchased and when the City meters are read, there is no way to get an exact comparison.

City Administrator Marty Byers stated on the back of his report is an update of the money spent so far for the WWTP Improvements Project.

Motion was made by Alderman Brant Cain, seconded by Alderman Guy Walker, to approve the February 2021 Consent Agenda as presented. The motion carried unanimously.

IX. **Items to Be Considered**

1. Consider and act upon approving line-item transfers for the 2020-2021 Budget.

City Administrator Marty Byers stated the reason behind the line-item transfers was to off-set the unexpected repairs on the Sewer Jet Truck.

Motion was made by Alderman Guy Walker, seconded by Alderwoman Lauren Bresch, to amend the 2020-2021 Budget as follows: \$5,000 to be transferred from Capital Improvement Project Water Storage Cleaning, \$5,000 from Repairs and Maintenance and \$1,000 from Travel and Entertainment, all line items in the Water and Sewer Fund to the Truck and Heavy Equipment Maintenance line item. The internal fund transfer totaling \$11,000 and having no effect on the Adopted Budget's previous total amount. The motion carried unanimously.

2. Consider and act upon approving Ordinance 2021-01 amending Ordinance 2014-16-09C Building Ordinance.

Motion was made by Alderman Brant Cain, seconded by Alderman Guy Walker, to approve Ordinance 2021-01 amending Ordinance 2014-16-09C to change the Building, Gas, Plumbing, Mechanical and Fire Codes from 2012 to the 2015 International Codes effective immediately. The motion carried unanimously
