I. Call to Order

The meeting was called to order at 6:00 P.M. by Mayor Pro-Tem Gary Lovelace.

II. Invocation

The Invocation was led by Alderwoman Lauren Bresch.

III. Pledge of Allegiance

The Pledge of Allegiance was led by Mayor Pro-Tem Gary Lovelace.

IV. Consent Agenda – May, 2024

Mayor Pro-Tem Gary Lovelace asked to approve the Consent Agenda Items including City Administrator's Report for May 2024, Police Department Summary for May 2024, Fire Marshal's Report for May 2024, Permit Report for May 2024, Monthly Financials for May 2024, and the Minutes of the May 21, 2024 Regular Meeting. The Water Department Summary for May 2024 was completed late and on file.

Marty Byers informed the City Council members of the glass breakage to the front of the building and informed the members we were currently looking at several options of repair. He also informed the council of the unexpected emergency expenses the city will incur to repair and replace old and backed up sewer and water lines on Country Club Road.

Motion was made by Alderman Brant Cain, seconded by Alderman Charlie Hunt, to approve the May 2024 Consent Agenda Items as presented. The motion carried unanimously.

V. Open Discussion

1. A discussion between the Focus Group members and Council regarding their experience with City Department Heads and possibly their suggestions for the City.

Members of the Focus Group expressed their appreciation and gratitude of being selected to serve as a member of this group. They expressed the knowledge they gained learning the operations of the City was very informative. They were very impressed with the personnel responsible for the City operations. Their main concern was our infrastructure as we continue to grow. The Council thanked them for their willingness to serve and concern for our City.

VI. Items to be Considered

 Discuss, consider and act upon approving Resolution 2024-02 selecting GrantWorks as the soliciting, planning and management service provider to assist the City with the development, adoption and implementation of modern and resilient building codes and flood damage prevention ordinances for the Community Development Block Grant – Mitigation (CDBG-MIT) Resilient Communities Program (RCP) through the Texas General Land Office. The amount of this grant will be approximately \$300,000.00.

A motion was made by Alderman Guy Walker, seconded by Alderman Brant Cain, to approve GrantWorks as the administrator for the Resilient Communities Program.

The motion carried unanimously.
